The students of campus colleges have to pay the fee through B Challan (which is available in the college office) in favour of the **Registrar, TU, Examinations Accounts** payable at State Bank of India, Telangana University Branch (Code No.13804), Nizamabad – 503 322. No action will be taken unless the application form is accompanied with a photocopy of the memorandum of marks. In no case, the fee is refundable.
